### **Bird News**

August saw few birds of note, many were still moulting and the warm dry conditions did nothing to provoke much activity.

A trip along the Pier to Pier way produced 70 Swallows at high-tide at Tutshill Sluice with a Hobby, heard but not seen.

There were also 60 Redshanks, a couple of Curlew and a family of five Egyptian Geese.

A couple of days later at the Channel View section of the sea wall half a dozen Stonechats suggested a productive nesting season.

On the wader front 25 each of Ringed Plover and Oystercatcher with a couple of Dunlin and a Grey Plover signalled the beginning of Autumn migration. A Wheatear on the Dowlais section observed by John Croxton indicated likewise. A Barn Owl was hunting over Congresbury Moor at dusk on the 12th, the first report from there for several months.

On the 22nd a flock of 40 Swallows had a late Swift with them and there were three Cattle Egrets feeding amongst the cattle.

The hot weather encouraged a lot of people to the Marine Lake in Clevedon and two friends were startled by a Peregrine shooting low over their heads carrying a blackbird as they were swimming.

There were several Kingfisher reports from Wemberham but the most unusual was one which flew across the B3133 by the Little River in front of the observer's car!

Moorhens had lots of young in Wemberham and Biddle Street Rhynes, a Kestrel was seen occasionally and by the 21st the large gulls were moulting, 200 Herring and 100 Lesser Black Backs by the River Yeo. The next day two Hobbies were around the pylons between Kenn and

Kingston and a Red Kite passed over the

same area.

### **Update from Tessa Munt, MP for Kenn**



I've had a busy August here as Parliament takes a break.

I'd like to thank all of you who've written, called and met me in my 'surgeries' to tell me what you care about, be that of local, national or international interest.

One of the most pressing issues for this area is the Environment Agency's inability to carry out maintenance on our main rivers, confirmed by letter to riparian landowners. The Agency's funding has been slashed in recent years.

Our complex network of streams and rhynes lead into the main rivers, and these waterways require on-going

maintenance to ensure that when it rains, water can get away to the sea.

Our climate is changing, and rain falls in shorter and harder bursts which can cause catastrophic local flooding in a very short time, so solutions to regular maintenance of our waterways have to be found, and swiftly.

I've raised this situation with the Chief Executive of Somerset Drainage Boards Consortium, and with the Flooding Minister, and I'll keep you updated.

The Government has indicated that MPs will consider the following over the next four months:

- Mental Health Bill
- Bus Services Bill
- Sustainable Aviation Fuel Bill

- Victims and Courts Bill
- Pension Schemes Bill
- Elections Bill
- English Devolution and Community Empowerment Bill
- Diego Garcia Military Base and British Indian Ocean Territory Bill

The Government may also introduce:

- A Rail Bill
- A Hillsborough Bill
   A Sentencing Bill

A Cyber Security and Resilience Bill

### **Our Monthly Missive from The Limes**

A couple of issues ago I described my woes with my solar panels and how the panels clearly didn't know that they should be more reliable than in fact they turned out to be. I mentioned that two panels had failed and were being replaced. Two out of 15 panels is an unacceptable failure rate but at the time I wrote this up I didn't know that worse was yet to come.

Some days later, on close inspection, I found two other panels were showing signs of charring and damage. That is now a failure rate of over 25%, so what do I do? The statistics say this should not happen. My current views on "statistics" are better not being published.

Clearly I have to do something. Although there are signs of damage my system is generally safe as it is ground mounted, away from the house and so there is no danger of the house burning down as with roof mounted systems.

However the less panels that are fully operational the less income I receive from them.

After some research I have decided to scrap all the existing panels as I have no surety that the remaining panels will not fail also.

The original system was set up on the initial Government Feed In Tariff scheme (FITs) and still has some years to run. Under that scheme I receive an amount per unit of electricity exported to the grid, which is over twice what I pay for electricity from the grid. In theory, on that basis, I would not use any electricity in the house when the sun was shining but keep the heavy use for the evening or when the sun was not shining. However in practice I don't need to do this as the meter system is arranged so that I get paid on what the panels generate, irrespective of where it goes.

Anyway I am going to replace all the panels. The deadline for this article is Tuesday and men are coming to change the panels on Monday and I'd like to tell you how it went but that looks a bit tight. We'll see.

The original FIT scheme was deemed too generous by the government and a few years after it started, the tariffs were slashed. (This is hardly surprising as what business with any sense would pay people not to use their product and in fact pay them twice as much to make the product themselves and sell it back to them?) Anyway, little notice was given and orders were cancelled and some installers went bust. The situation has changed again over the years and now bears no resemblance to early schemes.

The deal nowadays works like this. If you have solar panels installed you can export the electricity to the grid (but you will need a smart meter). The electricity suppliers can pay you what they feel like but it cannot be zero. The current rates are around 4.5 to 5p per unit. A far cry from the original and only a fraction of what you pay for electricity. According to my PV consultant, based on current costs that will take 16 years for you to recoup a typical installation investment.

There are two ways to handle this and make life better. The first is to make sure you use as much of the electricity you generate yourself, so you lessen your imports from the grid.

This is why the small print from some installers says their figures on how great a deal they offer are based on people being at home during the day. I guess if you are out at work you can set washing machines etc on a timer but modern homes have many other gadgets consuming electricity all the time – think of your broadband, fridges, TV's (even on standby) which all add up.

Someone told me that his house is using 300 watts per hour due to items which are constantly on. That alone equates to consumption of around 7 units a day or roughly £2 per day on your bill or £750 per year! Personally I think his figure is above what I'd expect but then I've never measured my usage.

Before I come onto the second alternative let me throw in an additional complication. You may remember the old white meter tariffs and cheap rate electricity deals. With the advent of electric vehicles and how to charge them at home, there are tariffs where you get cheaper electricity at night so you could do your washing etc overnight and save money that way. (I am assuming that readers have an idea of what appliances consume a lot of electricity and which ones have minimal demands. Sometimes people can get confused and turn off something which hardly uses any electricity!)

The second option is to add batteries to your PV system. This can double the installation price of your system and you have to factor replacing batteries every 15 years or so. If sized appropriately you don't have to worry about when to switch on the heavy appliances etc. as they will get their electricity from the battery (which is charged by solar or by cheap nighttime electricity from the grid). It is becoming more popular but make sure you do your research. The problems I have with the idea of this system are firstly that lithium batteries are not as environmentally friendly as the media would have you believe. Lithium is relatively common but there are a number of troubling news items describing locations targeted for mining which will ruin some areas of outstanding natural beauty or where mining will devastate communities. Furthermore, processing the mined lithium is quite a nasty process, often quite polluting. Dealing with old batteries at end of life is also problematic.

My second issue with batteries is you need to decide where to put them. House, garage, outside? You must do a risk assessment. In general, modern lithium batteries are quite safe – according to the statistics! You are unlikely to have problems. However if you do, the results can be quite devastating. An article by the BBC (I think) some years ago said that an electric bike battery contains the same energy as 6 hand grenades! The batteries used in a PV installation are many times more powerful and if they catch fire they are very hard to put out. I believe fire brigades are still researching the best way to do this. Some insurance companies require you to notify them as well.

So back to my system. I have some years to run with the old FIT scheme so it makes sense to keep my system running more or less "as is". When the scheme expires I will have a rethink. I'm not committed to having PV for ever. This may upset people but I'll say whatever you or I do about PV is not going to make an iota of difference in saving the planet.

It might make you feel good however. If used carefully it might even save you money!
